Implementation of Article 10 of the Fissionable Materials and Ores (Recording) Decree

The Minister of Economic Affairs.

Having regard to Article 10 of the Fissionable Materials and Ores (Recording) Decree (Bulletin of Acts and Decrees 1969, 471).

Decrees:

Article 1

In this Order the following terms are defined as follows:

Decree: the Fissionable Materials and Ores (Recording) Decree (Bulletin of Acts and Decrees 1969, 471):

Commission: the Commission of the European Atomic Energy Community;

'AKO' form: a form declaring the receipt of fissionable materials or ores in accordance with the model appended to this Order as Annex I;

'AKV' form: a form declaring the holding of fissionable materials or ores in accordance with the model appended to this Order as Annex II.

Article 2

A declaration concerning the holding of fissionable materials or ores for nuclear purposes under Article 5 or Article 7 of the Decree shall be made by submitting two certified copies of each of the documents that the person required to make the declaration under Articles 5, 7, 9 and 10 of Commission Regulation no. 8 (Official Journal of the European Communities of 29 May 1959) for the calendar month concerned is required to submit to the Commission.

Article 3

- 1. A declaration concerning the holding of fissionable materials or ores for non-nuclear purposes under Article 6 or Article 8 (1) or (2) of the Decree shall be made in duplicate separately for the fissionable materials or ores received in the calendar quarter concerned and those held on the last day of that quarter, using an 'AKO' and 'AKV' form respectively.
- **2.** Separate forms must be used for a declaration concerning fissionable materials and a declaration concerning ores.

Article 4

A declaration to which Article 3 applies – without prejudice to the provisions of that Article – shall be made separately for fissionable materials or ores that are subject to special control by a foreign state or an international organization pursuant to an agreement entered into for or including the Netherlands or acceded to for or including the Netherlands.

Article 5

This Order may be cited as the 'Fissionable Materials and Ores (Declaration) Order'.

Article 6

- **1.** This Order shall be published in the Government Gazette.
- 2. It shall enter into force on the date on which the Decree enters into force.
